

Letter to CARB on AB617 – South Sac/Florin

Main takeaways:

- Community must remain a priority to receive implementation funding
- Emphasizing necessity of long-term funding to develop and implement a CERP
- Time to build local capacity and will ensure a more community-led CERP process
- Anticipate nomination for year 2025, after CAMP implementation

Examples of ongoing local projects to reduce emissions:

- Supplemental Environmental Projects Using violation fees for projects proposed by local community orgs
- Unidentified Source Inspection Program ensure businesses are complying
- Work with the community on incentives project selection priorities



Pepsi/Tesla Incentives Project Update

- Based at Pepsi Bottling Plant in South Sac/Florin (Gerber & Reese)
- Trucks routinely drive in the community and Hwy 99 delivering beverages throughout Sacramento region
- Replaced 18 diesel semi-trucks with zero emission Tesla Semi trucks including charging infrastructure
- Trucks run on 100% renewable energy from SMUD
