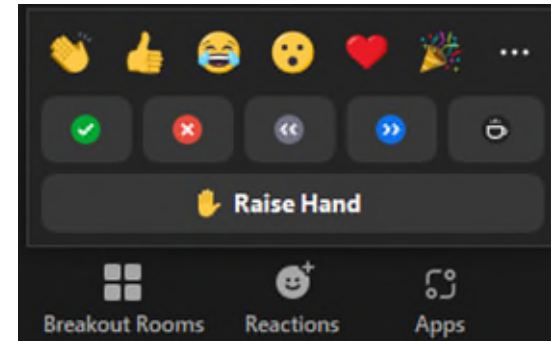

Recent TCC Incentive Work

- 2021 Incentive Solicitation
 - \$18 million
 - On-Road Trucks and Buses
 - Off-Road Equipment - Agriculture and Construction
 - Infrastructure Support for Clean Advanced Technologies
 - Funding Streams Included CAP, Moyer, SECAT, FARMER, and Prop 1B



Sac Metro Air District Incentives – Project Criteria

- Application and Approval Process
 - Competitive Solicitation from 3-29-2021 to 5-28-2021
 - Ranking criteria vetted by Steering Committee, and District Staff prior to solicitation
 - Applications were ranked by five criteria at one point each
 - Location in AB 617 Florin South-Sacramento Community
 - Benefiting a Disadvantaged Community
 - Location in an AB 1390 Designated Community
 - Projects with Community Support and/or interagency partnership
 - Complete applications ready to be funded and delivered (1st come/1st serve)
 - Projects reviewed by Steering Committee for final selection

Solicitation Results

- 158 Applications Received totaling \$57M requested funds
- 45 Applications Funded with \$18M available funding
- Remaining Projects placed on a Pending List
- Awarded Projects listed on Website

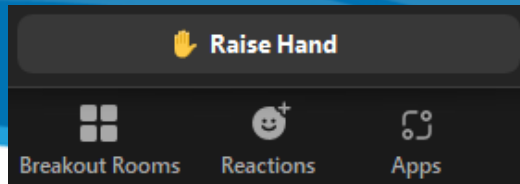
