The main agenda topics for this meeting were:

- Outreach Subgroup Report Back
- Recap Discussion on Land Use and Air Quality Impacts (Steering Committee moved to postponed to future meeting due to timing constraints.)
- Collaborative Decision-Making Training (This item was Steering Committee members only, there are no notes.)

Meeting Takeaways:

- All Committee members introduced themselves and their connections to the community to the newest member representing the Power Inn Alliance.
- The District provided updates on the following:
 - A Steering Committee member has changed their community affiliation and now serves on the Committee as the official representative of United Latinos.
 - The agenda does not include time for discussion on Phase 2 air monitoring data due to an error with the lab reporting making the data difficult to use. The District is working with the lab to resolve this and get the air quality data to the Committee as soon as possible.
- The outreach subgroup provided a report back on their ideas for outreach and communicating air quality data to the community. They provided a list of potential target audiences for engagement and identified various outreach methods. The subgroup members discussed the need for ranking which audiences and which types of information are priorities for engaging with the community.
- A member of the public discussed her recent meetings with other AB 617 community steering committees and their best practices for collaborating with community organizations on outreach and engagement.
- The committee discussed the idea of developing a survey based on successful surveys from other local groups.
- The District reviewed the results of a recent Committee member survey to prioritize future agenda topics.
- A member of the public commented that it would be premature to start discussing developing a Community Emissions Reduction Plan (CERP) before speaking to the community and identifying their priorities. They urged greater public participation at meetings and putting out requests for proposal to the community for support in developing a CERP.

Action Items:

- The Committee decided to postpone the District presentation on Land Use and Air Quality Impacts to the following meeting to allow sufficient time for Committee discussion.
- The Outreach Subgroup will meet again to discuss priority audiences and methods for outreach and provide a report back at the May meeting.

Steering Committee Decisions:

- The meeting notes from the March 23, 2021 Steering Committee meeting were approved unanimously.
