Required Documents Checklist

Prior to applying to the CC4A program, please prepare the following required documentation. Your application will not be considered complete, unless you submit the following documents.

How to Access Your Tax Return Transcript or Letter of Non-filing

You may request your document free of charge from the IRS through any one of the following options:

1. Online download
2. Online request by mail
3. Fill out Form 4506-T to request by mail or fax.
4. Schedule an appointment at the IRS office
5. Call to request by mail

Tip: We highly recommend getting your document through Online Instant Download (Option 1).

Option 1: Online Download

This section provides detailed, step-by-step directions for each of the above options. Tip: When going to the IRS website to request your document, use the Internet Explorer browser to allow for instant document downloads. We also recommend submitting the request on a computer rather than on a smartphone device. Reach out to your Case Manager if you require additional assistance accessing the IRS. 1. Start by going to IRS [here](https://www.irs.gov/individuals/get-transcript). (https://www.irs.gov/individuals/get-transcript)
2. Click on “Get Transcript Online.”

Request Online

What You Need

If you don't have an existing IRS username or ID.me account, have your photo identification ready.

What You Get

- All [transcript types](#) are available online
- View, print, or download your transcript
- Verify your identity once, and you can easily return later to get a transcript or use other IRS online services

3. If you do not have an account, click on “ID.me Create an account.” If you have an existing account, click on “Sign in with ID.me” and proceed to Step 12. Note: Using ID.me requires access to your email and cell phone number to receive text.

If you have an existing IRS username, please create a new ID.me account as soon as possible. We're bringing you an improved sign-in experience. You won't be able to log in with your existing IRS username and password starting in summer 2022.

If you're a new user, please create an account with ID.me.

Transcripts

View, print or download information from your tax returns, account transcripts, W-2s, 1099s, and more.

14. If you filed taxes, select the 2023 Return Transcript. If you did not file tax, select the document with * that indicates Verification of Non-Filing Letter.

Return Transcripts

These transcripts show most line items from your Form 1040-series tax return as it was originally filed, including associated forms and schedules. Lending institutions offering mortgages often accept return transcripts.

Option 2: Online Request by Mail

1. Start by going to IRS [here](#).
2. Click “Get Transcript by Mail.”

Alternative to Requesting a Transcript Online

We recommend requesting a transcript online, since that's the fastest method. If you can't get your transcript online, you can request a tax return or tax account transcript by mail instead.

What You Need

To request a transcript by mail, you need your mailing address from your latest return.

What You Get

- Tax return or tax account [transcript types](#) delivered by mail
- Transcripts arrive in **5 to 10 calendar days** at the address we have on file for you

If you need more than one copy of your transcript you are allowed to make copies for your personal records.

Option 3: Fill Out Form 4506-T

To submit request via mail, you must fill out Form 4506-T available [here](#). If you do not have a printer, request A Case Manager to mail a copy of the form. Completed forms must be mailed or faxed to the IRS at the following address:

Option 4: Schedule an Appointment at the IRS Office

In the case the IRS is unable to verify your identity or past records, it may be necessary to schedule an in-person appointment at your local IRS office. Option 5: Call to Request by Mail

The IRS has an automated self-service phone that can be used to order a Tax Return Transcript. Call (800) 908-9946. Note: You will not be able to request Letter of Non-filing through phone service.

Household Income Affidavit Form – Notary Services

Applicants who did not file taxes must submit a Household Income Affidavit. You must use a notary service to verify your Household Income Affidavit. Please make sure to bring an identification card with you when visiting the notary. Here are locations to help access a notary:

- Most UPS locations offer notary services. We recommend calling in advance to check if notary services are available and whether you can walk in or need an appointment. Find the nearest UPS store [here](#). Notary service is estimated to cost \$15.
- Banks and credit unions offer notary services for free or for a small fee. We recommend calling your local branch to see if they are open and have a notary service available.
- American Automobile Association (AAA) members have access to free notary services. Please contact your local branch to see if they offer the service for you.

- Mobile notaries are available but come at an additional cost. A mobile notary will typically charge for their service in addition to their travel costs.

DMV Services

Online

DMV provides services online. Check the DMV website for a complete list of online services available [here](https://www.dmv.ca.gov/portal/dmv-online/) (<https://www.dmv.ca.gov/portal/dmv-online/>). Please note that you must create an online account with DMV to access these services.

Kiosks

How to Access Your Vehicle's Registration History

As part of your application, you will need to submit proof of vehicle registration for the past two consecutive years. If you do not have records of your vehicle's registration, you can access it through DMV. We recommend requesting the documents online to expedite the application process.

When accessing your registration history on DMV website, please have the following information ready:

- Driver's license
- Last 5 digits of your vehicle's VIN
- License plate
- Credit or debit card information

How to Change Your Address on Driver's License

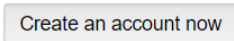
Your address on your driver's license must match your current address. If it does not, please update your address with DMV [here](#). We recommend updating address online as it is easiest and fastest. You will need to sign into your DMV online account. Please have the following information ready:

- Your old address
- Your current or new address

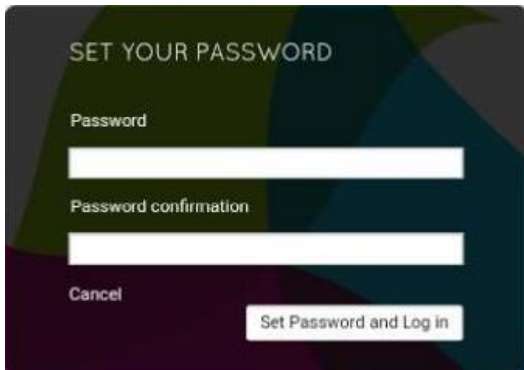
How to Create a Fluxx Account

To be considered for funding, you must create a Fluxx account and complete an online application. Please follow the instructions below to start.

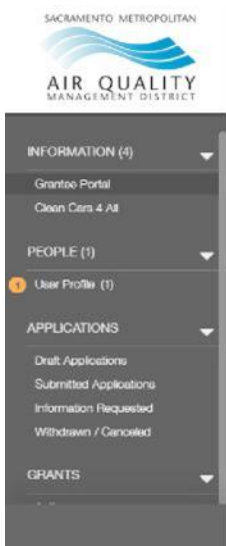
1. Create a user account in Fluxx to begin your online application [here](#).
2. Click on “Create an Account Now.”



3. Enter your information. Then, click “Submit Request.”
4. You will receive an email to verify your account and to create your password. If you do not see an email in your inbox, check your spam folder.
5. Set your password and click “Set Password and Login.” You will use your username and password to access your application.



6. Start the application by clicking “Apply for a Clean Cars 4 All Grant.”

Tips on Filling Out Your CC4A Application

We suggest the following tips to successfully submit your application:

- ✓ Complete the application using a computer.
- ✓ Remember to click “Save” periodically to save your application details. You can save your application and revisit by selecting “Save and Close.” Keep in mind you may need to login again to edit further.
- ✓ Complete the entire application BEFORE you click “Submit.” The application will not allow you to submit until you have filled out each section of the application.
- ✓ Required application fields are marked in bold.
- ✓ Only clear and legible supporting documents will be accepted.
- ✓ You must upload at least one document or image to the “Documents” section BEFORE you can “Submit.”
- ✓ If you need access to other information while filling out your application, we recommend doing so on a different tab in your browser. Or you can save your application and revisit later by selecting “Save and Close.”
